**County Hears Townline Plea** 

*TV Approves Agreements*

JACKSON JUNCTION - Annual approval was given to staff sharing with superintendent, maintenance director, transportation, vocational agriculture and school business/ HR with New Hampton and industrial technology with South Winneshiek.

During its June meeting, the board of education approved the sharing agreements.

Board members also discussed an agreement with The Lion Electric Company, of Joliet, Illinois, to help with securing an electric bus, pending grant approval for Turkey Valley as the company seeks to work with multiple school districts to bring electric buses to the districts.

If the district were to secure a grant, competitive bidding would still be required, but the current price quoted for the district is \$738,750.

Funding would be through a federal grant.

The district had previously applied for this but was not one of the winning districts selected for the previous year.

A School Safety Grant application was also discussed with \$50,000 per building or \$100,000 total for the district possible.

Turkey Valley has had its assessments completed with additional security cameras recommended. The district also has a visitor management system on its application.

Actual purchases will be approved when the district receives notice it has been awarded funding.

A resignation was approved for Honor Langreck with appointments: Jr High Volleyball Coach 23-24 for Hailey Gage; Jr High Football Coach 23-24 for Adam Hanson (pending certification); Jr High Boys Basketball Coach 23-24 for Simon Schmitt and Volunteer Baseball Coach for Simon Schmitt.

Work on 175th Street is continuing, according to Assistant County Engineer Isaac Wiltgen.

"Today, they are going to be prepping for the painting," said Wiltgen during Monday's supervisors' meeting.

A key right now is updating landowners and others affected on where crews will be and when work will take place.

"People tend to be a little bit happier if you let them know," said Wiltgen.

Meanwhile, blade work on Winneshiek County's gravel roads can move forward thanks to precipitation over the weekend.

"We haven't had rain in like forever," said Wiltgen.

That recent moisture will allow the Secondary Roads Department to have at least a few days to work on the gravels.

The department is also working to fill a staff opening. "Applications are due on Friday,' said Wiltgen. "We've County Sheriff's Office and WMT and its tractorcade.

Langreck said WMT corporate had apologized to the sheriff for disparaging comments regarding his reluctance to utilize staff on the clock for a minimum of four hours to provide traffic control for a private entity.

Consensus by supervisors was that the sheriff was prudent in that decision.

"It's not a good use of our money," said Supervisor Shirley Vermace.

Langreck also pointed to a possible reason that WMT might want to stay on positive terms with Winneshiek County.

"The rumor mill has it they want to come to Decorah next year," said Langreck.

Supervisors also heard from Rhonda Olsgard about Townline Road.

Olsgard reminded supervisors plans going back 20 years

### Judge Stops Sword Trial Proceedings

HAWKEYE – A judge has ordered proceedings suspended in an attempted murder trial for a woman accused of going after a man with multiple swords.

Kim Renee Cannon, 58, of Hawkeye, is accused of attacking her victim back in Jaunary with a pair of swords, injuring him with multiple lacerations to the head and one cut that had gone through his eye socket, leaving him bleeding following the assault.

According to a sworn statement in court records by Deputy Joshua Barker, the defendant allegedly attacked the man with one sword, left him injured and then came back with another sword to continue attacking him.

When law enforcement arrived, she was found to be in the kitchen, blood on her face and clothing and the victim on the bathroom floor as the defendant refused to follow law enforcement orders to leave the house, so the victim could be tended.

Bond was set at \$25,000 with the defendant eventually posting it as a protective order was served on the defendant.

Her trial was original set for May 10 as she had entered a plea of not guilty.

Now, the court has ruled to suspend proceedings pending a competency hearing on psychiatric grounds, with the judge finding "probable cause that the defendant is suffering from a mental disorder."

### **Remaining Prostitution Cases Headed for Trial**

FORT ATKINSON – Following plea deals for multiple prostitution suspects, remaining cases for subjects involved in pimping, prostitution and a client are moving ahead to trial after arrests that began in January at a residence in Fort Atkinson.

Jenna Beth McLaury, 30, of West Union, has entered a plea of not guilty and is set for trial Aug. 16 at 9 a.m. in Fayette County while Kaylee Jo Harting, 38, of Aurora, has also entered a plea of not guilty with trial set for July 2 at 9:30 a.m. in Winneshiek County. Both women are accused of prostitution.

Trent Jason Fitzpatrick, 53, of Oelwein, who is accused of pimping, will head to trial Aug. 23 at 9 a.m. in Winneshiek County.

Accused client Bradley Joseph Kamaus, 49, of Fort Atkinson, has likewise entered a plea of not guilty. After a judge rejected Kamaus' request for a public defender, his new attorney successfully filed for a continuance, arguing she had just met him and needed time to prepare a defense. Kamaus is the only defendant not utilizing a court-appoint-

ed defender.

Trial is set for Sept. 20 at 9 a.m. in Winneshiek County. So far, Nicole Burgos, 29, of Oelwein, and Ashley Rochford, 38, of Oelwein, have both taken plea deals after the women were charged with prostitution.

Fitzpatrick, for his part, has ignored the warning of his defender and insisted on a trial, with a specific note that he could be liable for part of the costs of his own defense for pursuing a full trial, court records note. The court granted an exemption to the normal public defender pay for Fitzpatrick beyond what is typically allowed.

The multi-county investigation has spanned months with trials now set to take place in two counties and with defendants drawn from three counties with multiple law enforcement divisions taking part in the investigations that resulted from a bank employee noticing suspicious activity as the alleged prostitutes sought to get paid, with payments in hundreds of dollars per each time allegedly involved.


The district will be selling 225 chrome books including chargers at \$10 each. They will be sold July 10 and 11.

had been proposed for Townline Road but never followed through.

A request for commercial application for dust control on the road were met by being informed that "without extreme" amounts of chemical such an effort would be a fool's errand.

"I feel like we've exhausted every effort to make it better," said Olsgard.

With high traffic numbers and its importance, Townline Road should be paved, rather than remaining gravel, according to Olsgard.

Supervisors were sympathetic but some issues are in the way of undertaking work right now.

Vermace said while the Engineer's Office is unfilled, things could not be begun.

Moreover, funding is an issue.

"Something would have to get pushed. There's not any more money," said Auditor Ben Steines.

Funding is not insignificant.

"There's a reason you haven't turned a gravel into a hard surface road in 20 years," said Steines.

Langreck agreed.

"We can't keep up the ones we got," said Langreck.

Maaten raised the idea of the county doing the work of recording meetings of the Board of Supervisors for online viewing.

The county attorney said years before police officers used to be reluctant about adding body cameras to their uniform.

Today, you would have to pry the cameras from officers since the footage has often helped to exonerate officers from false complaints.

Van Der Maaten said private recording of the meeting broadcasts has been taking place with the Winneshiek County meetings viewable online already, just not in an official capacity.

"I think it's time to give some consideration," said Van Der Maaten.

Steines raised a concern about the county's responsibility with regard to the creation of a new form of public record, one that would be required to be maintained.

What happens when and if a private vendor, such as You-Tube has its site go down and how this might affect the county's liability was raised.

Van Der Maaten said he would work to get some information together and then report back to the board of supervisors with the results of what he is able to find out on the subject.
