# More locals come forward to share experiences with ex-Toledo officer

Most of Tama-Toledo first heard of ex-Toledo Police Sgt. Kyle Howe after the late March traffic stop of Shyla Wolf, but there are some who knew his name long before that. The 16 videos posted on the Tama Toledo News Chronicle Youtube page cover five incidents that show Howe's handling of the situations, which have been widely condemned and criticized. However, it is known that these five incidents are just the tip of the iceberg.

One such run-in took place back on July 30, 2022. A pair of teenage boys were pulled over by Howe after they were seen in Toledo Heights Park after dark at 9:55 p.m. Toledo Heights Park closes at 10 p.m.

It is also stated by Howe that he knows that other people were currently in the park, but there was only one of him. Howe took the 16-year-old driver back to his police cruiser for an interrogation.

Howe's body camera video shows him talking to the boy, asking if the two were intoxicated or smoking weed. Howe accuses the teenager of having enlarged pupils and tells him he may ask for a urine sample. After several minutes of talking to the driver, Howe then walks back to the boy's car and talks to the 16-year-old passenger.

At one point, the teenage passenger asks to call his parents; Howe said no and to get out of the car. Howe opened the passenger's side door. The teenager, still buckled in his seat says, "You can't do this."

Javier was the shortstop, second baseman, and third baseman for the Cedar Rapids Reds (Kernels) from 1987 to 1991.

The biggest issue discussed at the May 1 Tama County Board of Supervisors meeting was not wind turbines or solar, but the new public comments format. An idea thought up by Supervisor Faircloth, the public comments portion of the meeting was changed from an open conversation to a more muted exchange.

Any citizen wishing to talk was to address everyone from the front of the room with only five minutes slat-

At no point were the supervisors supposed to comment or reply to the comments given. The half an hour between 9 and 9:30 a.m. saw multiple citizens stand to address the supervisors, who sat silent and blinking. The large silences that filled the room between comments were only

# Settlements with ex-STC staffers total \$1.17 million

#### Bagnall, Frakes, Jantzen speak out after agreements finalized By ROBERT MAHARRY

Three former South Tama County staff members who filed age discrimination lawsuits against the district and former Superintendent Jared Smith related to their termination or non-renewal of employment have reached out of court settlements totaling \$1.17 million, according to documents shared with the News Chronicle.


Brent Bagnall, the former activities director and assistant principal, received two payments as part of his agreement, one in the amount of \$214,077.72 and another in the amount of \$50,000. The law firm representing him, RSH Legal, received a payment of \$210,922.28.

Roy Frakes, the former high school principal, received two payments, one in the amount of \$175,697.46 and another for \$50,000. RSH Legal also received \$169,302.54 for representing Frakes.

Former Food Service Director Sandy Jantzen received two payments, one in the amount of \$119,770.44 and another for \$50,000. RSH Legal was paid \$130,229.56 for representing her.

All three plaintiffs filed their original suits on Dec. 15, 2020, and Bagnall's case was officially dismissed last December, followed by Jantzen's in January and Frakes'
