## Six area bands set to jazz it up at state championships

MOC-FV hoping to hit high note again

REGIONAL-Six N'West Iowa high school jazz bands are set to perform at the Iowa Jazz Championships on Tuesday, April 4, in

Among them is Class 3A MOC-Floyd Valley High School's jazz ensemble, which competed in five Iowa contests this year and walked away with five first-place

"This year's jazz band is playing at a very high level. I am excited to see how the judges at a highquality contest like IJC rank us," said Matt Honken

He directs MOC-Floyd Valley's top jazz band, a 22-member ensemble that is designated Jazz I. The high school has three jazz bands with 55 members in total.

The band's competition season included the Iowa Lakes Jazz Contest in January in Estherville, the University of Northern Iowa's

## Court documents provide more info on murder charge

#### Kassel arrested in death of mother

SHELDON-Bond has been set at \$1 million for a 41-yearold Rock Rapids man accused of murdering his mother at her home in Sheldon on Thursday, March 23.

Nathaniel Byron Kassel was arrested about noon Friday, March 24, in Flandreau, SD, in connection with the death of 62-year-old Jody Lynn Duskin.

He has since been extradited to the O'Brien County Jail in Primghar, where he faces charges of first-degree murder, a Class A felony; felon in

possession of a firearm, a Class D felony; operating a vehicle without the owner's misdemean-



counts of fifth-degree theft, simple misdemeanors.

Criminal complaint documents filed in O'Brien County District Court by the Sheldon Police Department provide more information on the incident than initially provided in news releases by the lowa

## Kassel accused of shooting mom, taking her car

Continued from page A1 Division of Criminal Investigation through the Iowa Department of Public Safety.

Sheldon police chief Scott Burtch wrote in his report that Kassel "willfully, deliberately, and with premeditation killed the victim, his mother."

The report stated Kassel was residing with Duskin at the time and messaged other family members, stating "I'm killing Jody" at approximately 8:47 p.m. Wednesday, March

At approximately 11:30 p.m. that same date, Kassel "was overheard in a phone conversation stating he made a mistake and hurt someone."

Kassel was in possession of a handgun at approximately 4:30 p.m. on the same date, according to two witnesses, according to the police chief's

Kassel communicated with individuals in the early morning hours of Thursday, March 23, that Duskin was sick and could not go to work.

The report stated Duskin was shot in the head in the south bedroom of 604 Fourth

A .45-caliber casing and a bullet were located.

Three empty handgun containers also were located in the residence. One of the containers was for a .45-caliber hand-

Kassel's arrest stemmed

from a 911 call to the O'Brien County Communication Center about a deceased female located at 604 Fourth Ave. at about 4 p.m. Thursday, March 23, in Sheldon. Duskin, who had owned the home since September 2020, was found by a family member, according to the DCL

When authorities arrived, they found Duskin deceased inside her two-story home.

An autopsy of Duskin took place last Saturday by the Iowa Office of the State Medical Examiner in Ankeny, and her death was ruled as a homicide.

Kassel was arrested Friday in Flandreau, SD, outside the Native Nations Cannabis Dispensary, according the Flandreau Santee Sioux Tribe

Flandreau Santee Sioux Tribe police chief Brian Arnold noticed a vehicle at the Royal River Casino & Hotel that fit the description given to department by the Iowa DCI. The vehicle was a 2013 Ford Edge owned by Duskin.

The tribe police coordinated with the Flandreau Police Department, Moody County Sheriff's Office, South Dakota Highway Patrol and Iowa DCI.

Kassel was taken into custody at the Brookings County Sheriff's Office in South Dako-

He was found to be in possession of two of the handguns - a .22-caliber handgun and 9 mm handgun - from Duskin's residence.

Kassel was extradited on Monday, arriving about 8 p.m. to the O'Brien County Law Enforcement Center.


A preliminary hearing is

scheduled for 1:30 p.m. Friday, April 7, in the O'Brien County Courthouse in Primghar at which time the judge will determine if there is sufficient evidence to continue the case.

Billy Oyadare, a state public defender out of Sioux City, was appointed as Kassel's attorney after Kassel signed a financial affidavit stating he is unemployed and therefore has no income. He also stated he owns nothing worth more than \$100.

Scott Brown, assistant attorney general of Iowa, will represent the prosecution on behalf of the state.

Funeral arrangements for Duskin are being handled by Jurrens Funeral Home in Sib-

## Rural Rock Valley to get extra paving

#### Sioux County puts three more miles on road plan

ORANGE CITY-The Sioux County Board of Supervisors have added plans to resurface some roads neighboring Rock Valley to the fifth year of the county engineer's five-year plan.

Rock Valley mayor Kevin Van Otterloo requested at the supervisors' March 21 meeting that the county eventually pave two routes on the city's south side. The first route is Fig Avenue from Highway 18 to 320th Street and then 320th Street west a half mile from Fig Avenue, which is now gravel.

The second route included 320th Street from Elmwood Avenue to Eagle Avenue, which is now a Level B maintenance road, then the gravel road from 320th Street north a half mile up Eagle Avenue to reach the city limits.

These two routes amount to about three miles

The total estimated cost for the project, which would include right-of-way acquisitions, grading and box culvert extensions, is \$7.54 million. The estimate was based on statewide average prices over the past year. Assuming 6 percent inflation, the total cost would increase to \$10.1 million in 2028.

There is a half-mile section of the Fig.

Avenue portion of the project where the Rock Valley city limits are on the centerline of the road. Rock Valley would be responsible for the project costs in this area, an estimated \$530,000 based on past-year prices or a projected \$705,000

These routes are increasingly used by trucks and other motorists seeking to get to Rock Valley's industrial locations, but the Level B maintenance road has caused problems for trucks since the first eighth of a mile has gravel provided by a homeowner, making that road appear to be better maintained than it

"You have a lot of steel trucks coming in from Sioux City, and their GPS is taking them down that dead road," Van Otterloo said. "Right now, when they turn on that dead road and see they can't go down it, they have no chance to turn around in a semi. They actually have to back up across that blacktop and hope no cars pop up over that hill.

For the county to take on the project, it must first be added to the engineer's five-year plan, requiring the supervisors' approval. By putting the project on the five-year plan, the county is under no obligation to do the project.

Sioux County engineer Joel Sikkema said he would want to talk more with Van Otterloo about which of the two routes would be higher priority if the county had to tackle them in different

Upgrading the Level B maintenance road on 320th Street already is part of the five-year plans, due to begin in 2024. Once graded, the road would need to wait two years before it is hard surfaced so that it can properly settle.

"The challenge with this is going to be with the \$7.5 million estimated cost, we really need to figure out what all of our available options for funding are," Sikkema said.

He said that sources such as Revitalize Iowa's Sound Economy (RISE) grants could be one option, given the projects' nticipated benefits to Rock Valley's industrial businesses. In other matters at the March 21

meeting, the supervisors unanimously approved downsizing the number of members on the Sioux County Planning and Zoning Board from 11 to seven. Planning and zoning director Shane Walter said it is unusual among lowa's

counties to have so many people serve on that board, with five or seven members much more common. "A commission of 11 is kind of un-

wieldy sometimes. It's hard to get everybody at the meeting," Walter said.

To get down to seven members, Walter will ask if any current members are willing to step down. After that, it would come down to not replacing members who complete their terms until a sevenmember board is achieved.

Asbury went on to win Song of the Year, Worship Song of the Year and Worship Album of the

In 2020, "The Father's House" was released as the lead single for Asbury's third solo album "To Love a Fool." The song debuted at No. 16 on Hot

## Charges dismissed for one of two men after Sheldon arrest

#### Pot, guns allegedly found at residence

SHELDON-Charges have been dismissed for one of two Sheldon men arrested following a search of their home Jan.

The arrests of 64-year-old Kevin Glen Anderson and 61year-old Joey Lynn Espeland followed a search of at 217 N. Fifth Ave., according to the Sheldon Police Department.

A small white container with marijuana in it was found in a dresser that Anderson said was his. Multiple items of drug paraphernalia, such as onehitters, pipes and bongs, were found among his belongings as well as in common areas of the residence. Anderson admitted some of the items were his, according to the incident

A bag containing marijuana was found in Espeland's bedroom. Two .22-caliber rifles and a 12-gauge shotgun also were located in the residence. Espeland said the rifles were his while the shotgun was in a common area he had access to. Various items of drug paraphernalia, such as one-hitters, pipes and bongs, were found in his bedroom as well as in common areas of the residence.

Anderson was charged with second-offense possession of a

controlled substance — marijuana and possession of drug paraphernalia.

Espeland was charged with possession of a controlled substance — marijuana — third or subsequent offense, dominion/control of a firearm/ offensive weapon by a felon and possession of drug paraphemalia.

The search warrant stemmed from Anderson being arrested Jan. 20 on charges of driving while his license was denied or revoked and operating a motor vehicle without a required ignition interlock after a 2000 Chevrolet Silverado pickup he was driving was stopped on the 100 block of North Fourth

The pickup Anderson was driving was registered to Espeland. When an officer returned the keys to their residence, he detected the odor of mari-

Anderson pleaded not guilty to all the charges on March 18 in O'Brien County District Court in Primghar.

A pretrial conference for him has been scheduled for 9 a.m. April 17 with a jury trial slated for May 16.

The charges against Espeland were dismissed March 17 at the request of O'Brien County assistant attorney Rachael Becker after he was not indicted within 45 days as required by Iowa Rules of Criminal Procedure 2.33(2)(a).
