## **Crawford and Shelby County Community Foundations Spring Grant Program Now Open**

County Community Foundations are pleased to announce that applications are now being accepted from organizations providing charitable services. As part of this spring grant cycle, approximately \$130,000 is available to support nonprofit organizations and community projects in each county. The deadline to apply for funds through the online application process is February 1, 2023.

Beginning December 15, application details, a fact sheet, and a link to the application form can be found online by selecting Crawford or Shelby County under County Listing at www.swiowafoundations.org. Applications will only be accepted through the online system. There is a new grant application portal this cycle in Crawford County, all applicants will need to create a new account when first accessing the applica-

This cycle of grants is made possible through the State of Iowa County Endowment Fund Program and is funded by a percentage of the state's commercial gaming tax revenue, which is distributed annually to participating community foundations associated with counties without a state-issued gaming license. Only organizations providing services in Shelby County are eligible to apply. They must be able to demonstrate broad community/county support and be an IRS-approved 501(c)(3) public charity, a local municipality, or a fiscally sponsored project.

The Crawford and Shelby County Community Foundations aim to improve the quality of life in the counties by supporting community needs in the areas of civic engage-

The Crawford and Shelby of the grant program is to fund projects that will have a lasting impact. The Crawford and Shelby County Community Foundations will entertain requests for capital and program support. In Crawford County general operating support will only be considered for onetime, non-recurring circumstances that improve the capacity of the organization to fulfill its mission. Shelby County requests for general operating support will not be considered.

All completed grant applications will be considered at the March board meeting, with applicants being notified of funding decisions by the end of March.
