Jasper County Fair At-Large Director Reed Hiemstra was one of the people who tracked down the animal and helped make the situation safe for all those on the grounds.

"We just make sure we shut all gates and do what we can to try and get the animal corralled safely for it and us," Hiemstra said. "It ran back behind one of the buildings and trapped itself. We got ahold of the halter and got it tied up until we could get the trailer."

The animal was then loaded up and headed back home.

"Some animals don't like to be moved to different places and they react differently," Hiemstra said. "When I was little and in 4H I had an animal that drug me around everyday at home, but when I got to the fair she was fine. Some animals are fine at home but you move them to a new environment and they don't like it."

### JCARL building to become training facility for sheriff's office

### Building will be open to other departments across county for training opportunities



The former Jasper County Animal Rescue League building, which is owned by the county, will be renovated into a training facility for the nearby sheriff's office.

Following the regularly scheduled board meeting on June 27, sheriff John Halferty and sergeant Tracy Cross met with the county supervisors to discuss their proposal for the building. The sheriff's office staff and other first responder units throughout the county have struggled to find places to train for years.

By having a yearround facility devoted to interior and exterior trainings, Cross said would provide law

ment officials opportunities to utilize all of their tools and test themselves in a variety of different scenarios. For instance,

breach tools like rams or sledge hammers cannot feasibly be used on personal property.

"A lot of properties (used in the past) they ask that you don't damage anything. They don't want you shooting in the house with stun guns either because it can damage a window or a wall. Then we have to clean that stuff up or pay for it," Cross said, noting the JCARL building would be a marked training facility.

### Fine free! Newton Public Library no longer charging youth for overdue books

Library director says fines are not worth denying access to services

Newton Public Library is no longer going to charge children and teens overdue fines for late books, children's DVDs and STEM kits.

In a press release July 13, the library staff and its board of trustees announced that overdue fines go against the Newton Public Library's mission statement: "A community resource encouraging lifelong learning." These fines are a hindrance to its mission and "are not worth denying access to library services" for youth.

Which means children's and teen collection items that become overdue can be brought back to the book-drop or circulation desk with no penalty.

Currently, the checkout system at Newton Public Library notifies patrons of when books are due. The library will continue to notify patrons via email three days before the due date, three days and 14 days after the
