

# Search for birth mom, yields a brother

GARNER - Cheryl (Schlei) Farris of Garner was born July 23, 1951 at Booth Memorial Hospital Des Moines.

"Mom and Dad (Dale and Lillian Schlei, rural Klemme), brought me home on Nov. 7," Cheryl said. She knew from a young age she was adopted. When a school chum asked what it was to be adopted, she was told that Dale and Lillian got to "pick her".

"I had a wonderful childhood and wonderful parents," she said. "I just thought I was special."

However, about four years ago, Farris contemplated researching who her biological mother might be.

"I wanted to find out if there were any health concerns that I could tell my kids and grandkids. That's the main reason. Just to find the records and see what I could find out."

She was also curious to know if she had a half-brother or sister somewhere

Then, two years ago, the Iowa Department of Public Health opened up adoption records.

Cheryl's daughter, Hancock County Recorder Tracy Marshall, received the paperwork she needed to sign and send in to the State.

About 6 weeks later, Cheryl received a document stating her birth mother's name was Carol Schneekloth. The baby's name on the birth certificate was listed as "Pamela Kay." (Dale and Lillian had changed their adopted daughter's name to "Cher-

Cheryl learned that Carol became pregnant at age 16. It was a time when unwed teenage mothers typically didn't keep their babies. Putting the baby up for adoption was the norm.

She assumed that her birth mother was probably deceased and found her obituary on a website. Carol (Schneekloth) Hankins had passed away on June 12, 2021 at the age of 86.

"I found out that she had died just two weeks earlier," Farris said. " I didn't know quite what to think at first."

The obituary included a photo. The resemblance between Cheryl and Carol was apparent.

"I didn't know if he would even call," she recalled. "But I talked to the funeral home. An hour later, he called me." She introduced herself and asked John if he knew that his mother had a baby when she was 16 in 1951. (Jon was born in 1953)

"She had a little girl and that was me."

There was silence on the other end.

"It seemed to me like forever, but it wasn't," Cheryl recalled.

She explained she only wanted to know of any potential health issues - heart disease, etc. that could be inherited. She also told him that she had seen his mother's obituary and learned that she had recently passed away.

Then he started talking," she said. John had no idea of his half-sister's existence.

Later during the summer of 2021, they met at Mat's Place in Garner. Cheryl admits to being nervous at first.

"I didn't know what to expect," she said. Her son, Cody,, went with her. As it turned out, Jon also had brought his son along..

"When we got out of the car...they got out of their car. John came right over and hugged me," she said.

During that first visit, John talked about his family. He answered Cheryl's questions about family health to the best of his knowledge.

She learned that Carol worked for many years as a waitress at the Tall Corn Motel in Shenandoah. She was employed at Henry Fields Nurseries, and in later years, was a part-time caregiver for home-bound individuals in the Shenandoah area. She also enjoyed reading murder mystery books (something that Cheryl also enjoys).

John gave Cheryl an afghan his mother had made as a memento.

"Now when I call him, I say,

'Hello, little brother.' He says, word of caution. 'Hi, sis.' No one ever called

me that before. It's different


for both of us."

## Britt City Council appoints new member

The Britt city council had a lengthy agenda on May 2, including the appointment of a new member to the council and several public hearings.

Abby Post was appointed to fill the unexpired term of Chad Luecht who resigned in April. The term expires at the end of 2023.

The oath of office was administered to Post at the May meeting.

Public Hearings

Several public hearings on various matters were held with no written comments or objections.

The sale of property at 585 6th Ave. SE to Sandy and Joel Garza was approved. The Garzas agreed to pay \$1,500

plus publication costs to the city.

Heartland Asphalt was awarded the bid for a paving project on 2nd Street SW. Heartland's bid

\$173,636.65 was one of two bids received on the project, according to Wes Brown, project engineer from Bolton & Menk. The bid came under the engineer's estimate of \$185,000. The city also received a bid of \$220,099 from Black Top Services.

The first reading of an amendment to Ordinance 514 to increase residential and commercial water rates by 3 percent annually starting July 1, 2023, was held. A second reading will be on the June agenda.

The council approved var-

ious budget amendments to the budget for FY23 as presented by City Clerk Elizabeth Ibarra. The amendments are due to increases to employee health insurance, liability insurance and employee salaries.

In other matters:

The council heard monthly reports from the following department heads: librarian Linda Friedow, public works Director Vance Hagen, Police Chief Mark Anderson, Fire Chief Jon Swenson, Zoning Administrator Mike Boomgard.
