On Monday, Nov. 14, the school board approved shifting transitional kindergarten to a full-day class.

Marcia De Graaf, Hospers Elementary principal, explains the move. "In order to best serve the variety of needs of our fiveyear-old children, Transitional Kindergarten will become a fullday program starting at the beginning of the 2023-2024 school year. Our new elementary has the classroom space to support the change, and we are very appreciative board approved the additional staffing. Plans will begin to determine scheduling for the TK day, curriculum updates, and support services needed to coordinate a developmentally appropriate full-day TK program."

The move will allow TK children to ride the bus to and from school and help eliminate the need for part-time daycare.

"Deciding whether a child attends kindergarten or TK is sometimes a difficult one. Adding a full day of school for TK will ultimately set kids up for success, allowing students the time they need to learn at an appropriate pace and starting school off with a positive experience," said Russ Adams.

"I am so excited to add this program—we will be able to serve more young learners and make their first year within our district a positive learning experience," De Graaf added.
